

# Tackling the growing need for regulatory compliance

The threats to global supply chains are increasingly driving governments to tighten controls and mandate advance notice of import, export, and transit freight passing their borders. Similarly, more and more customs organizations require electronic customs clearance to replace paper documentation.

These measures place a heavy burden on cargo carrying airlines as well as ground handlers, forwarders, and shippers. Non-compliance can lead to freight being held, trader fines or even embargoes, which can impede the international flow of trade, increase costs, and undermine the effectiveness air cargo.
