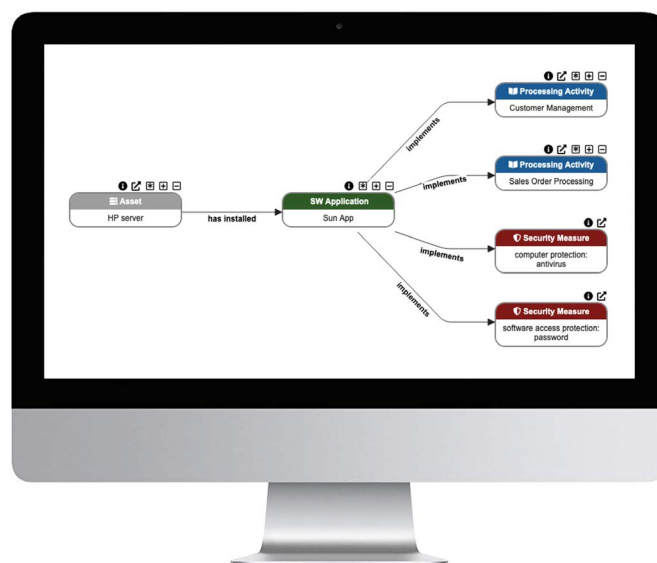
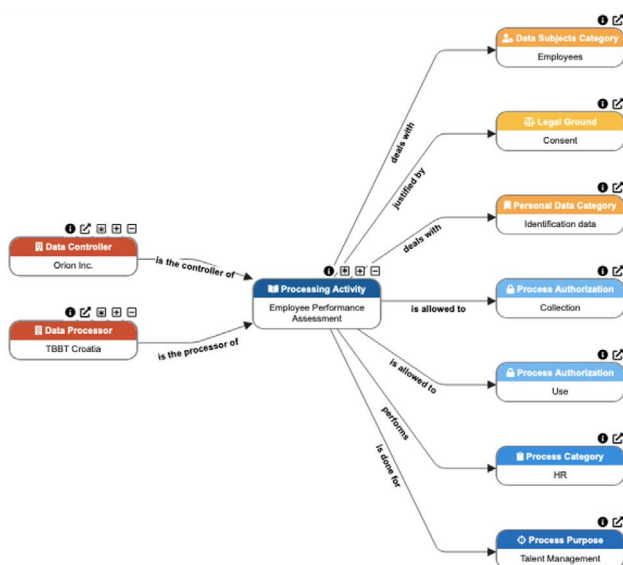

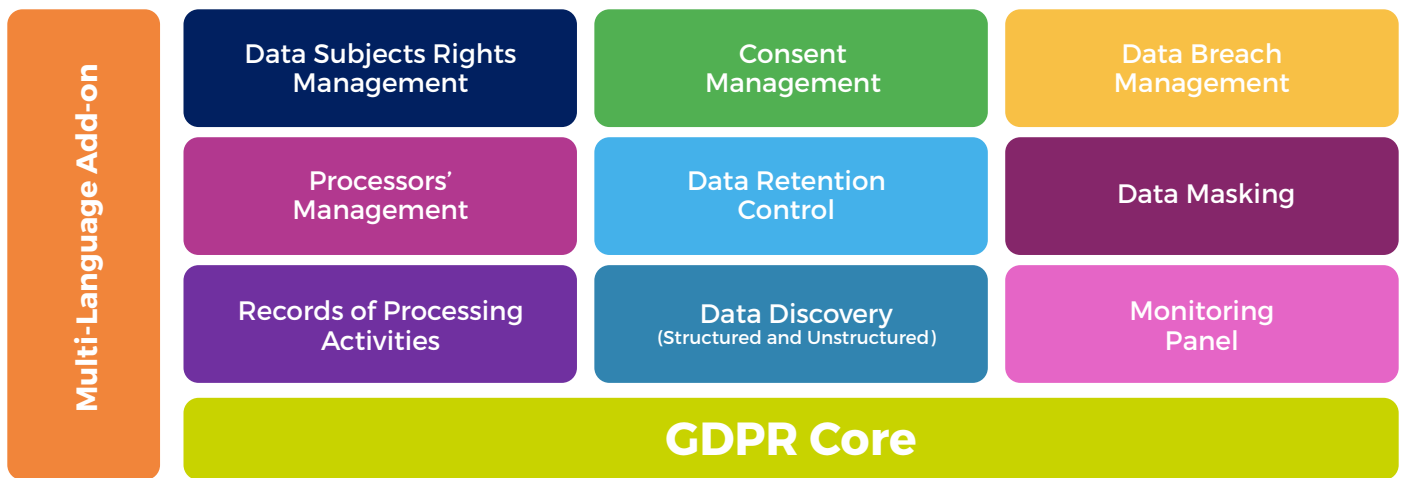
Primeur Data Privacy key differentiators include the following:
